Note: Student visa refusals: this charge does not apply where a student withdraws due to refusal of their student visa application. However, the University may calculate a refund in accordance with the <u>Education Services for Overseas Students (Calculation of Refund) Instrument 2024</u> (the Instrument), under the <u>Education Services for Overseas Students Act 2000</u> (ESOS Act).

4 Non-commencement — other international students

Where a commencing international student has paid a tuition fee deposit at the time of accepting their offer, and does not commence studies, or withdraws their enrolment in the semester of commencement, an administrative charge applies. The charge is based on the terms of the offer accepted, the tuition fee deposit paid, the reasons for withdrawal, and whether exceptional circumstances apply.

Note 2: The charge does not apply for a student who is exempted from payment of a tuition fee deposit, such as where the student is -

- (a) not eligible for a student visa, as the study is part-time internal; or
- (b) not eligible for a student visa, as the study is non-award internal or external study; or
- (c) an Australia award scholarship recipient; or
- (d) a current UQ student changing program.

Note 3: Student visa refusals: this charge does not apply where a student withdraws due to refusal of their student visa application. However, the University may calculate a refund in accordance with the <u>Education Services for Overseas Students (Calculation of Refund) Instrument 2024</u> (the Instrument), under the <u>Education Services for Overseas Students Act 2000</u> (ESOS Act).
