

# Crime101x - VEP Course Profile

This document outlines the course profile for a MOOC or MOOC+SPOC combination proposed as part of the Virtual Exchange Program. Included are descriptions of activities and assessments for the MOOC, and companion SPOC. For comparison the same information for the equivalent UQ on-campus course is provided. The aim is for the MOOC+SPOC to be as comparable to the on-campus course as possible given the constraint of a fully on-line delivery.

VEP students will be required to enrol in both the public MOOC and the private companion SPOC.

# **Course Aims**:

#### **PSYC2361**

The course aims to provide an introduction to how psychology can apply to law and the legal system.

#### Crime101x MOOC

This course systematically explores the effectiveness of the law and justice system from a psychological perspective. By experiencing a fictional case first hand, you will learn about the psychology of law and some of the misconceptions commonly held about criminal justice.

The SPOC provides VEP students with:

- access to additional materials from PSYC2361 not used in Crime101x;
- assessments to ensure comparable assessment to PSYC2361;
- a discussion forum for VEP students to communicate with course staff.
